1. General Statement

- 1.1 As stated in our education mission, we aim to produce students who are assets to Hong Kong, China and the world. The school offers an excellent learning environment, including appropriate teaching targets, effective teaching strategies, well-qualified staff, a student-centred curriculum and ideal teaching facilities. The school values the cooperation of parents, cultivates a desire for learning among students, fosters an ethos of a learning community, and aims to provide a happy and stress-free environment in which students can develop into righteous, responsible, knowledgeable, internationally-minded and independent life-long learners who can face the challengers of the future.
- 1.2 We are an open and diverse school committed to serving the needs of the Hong Kong community and developing our students to be internationally minded and global citizens who contribute to their community.
- 1.3 The school's pupils are mainly drawn from the local Hong Kong Chinese population, although we are committed to delivering education to all.
- 1.4 All nationalities, genders, cultural and religious denominations are welcome at the school.
- 1.5 As stated in our education vision statement, we believe experience and vision complement each other. We believe that each child loves learning and has different potentials. Provided that their interest is stimulated, that they are given appropriate guidance, that they are given opportunities to develop their confidence, that they are cared for and constantly encouraged, they will become outstanding people.
- 1.6 We aim to provide an inclusive, challenging, and stimulating environment for all of our students, including those with special educational needs.
- 1.7 CKY is committed to assisting students with different forms of varying needs, and the school site is disability friendly.

2. External Admission Criteria

- 2.1 All prospective Year 1 students seeking admission to CKY will be required to undertake a series of admission interviews to assess their level of competency in both English and Chinese;
- 2.2 For prospective Year 1 students, we take into consideration
 - i. applicants' school records and teacher recommendations;
 - ii. applicants' holistic development, character and attitude;
 - iii. parents' recognition of the school's vision and mission;
- 2.3 Insert students (i.e. those entering CKY after Year 1) must complete written examinations. If the applicant is successful in the written examinations, an interview will be arranged. The interview is used to assess whether the applicant understands the school and IB educational philosophy, and whether the applicant has the appropriate learning attitude and aptitude to pursue the IGCSE and IBDP at CKY.
- 2.4 The subject choices for applicants to IGCSE and IBDP applicants must meet the same entrance requirement as our own Year 8 and Year 10 students (see 3.1 and 3.2) and the equivalency of other qualifications obtained will be taken into consideration. Moreover, the subject choices must fit the school's IGCSE and IBDP option blocks.

3. Initial and Internal Admission Criteria

- 3.1 CKY students must fulfill the academic requirements of promotion to move onto the next year level (please refer to section 4 Academic probation and retention).
- 3.2 For progression to IGCSE programme, CKY students are expected to meet the school's expectations (refer to Section 4.4)
- 3.3 For progression to IBDP programme, CKY students are expected to attain a minimum of 3Bs and 3Cs in their IGCSE examinations, with the additional requirements as follow:
 - 3.3.1 A minimum of grade B in Cambridge IGCSE for all Higher Level subjects, except Mathematics
 - 3.3.2 A minimum of grade A in Cambridge IGCSE Mathematics for Higher Level Mathematics
 - 3.3.3 A minimum of grade C in Cambridge IGCSE for all Standard Level subjects, except ab initio

3.3.4 A minimum of grade C in Cambridge IGCSE First language English for Higher Level English B

3.3.5 Students who do not meet the above course selection requirements but achieved a minimum of 6Cs for their chosen IBDP subjects in their respective IGCSE grades are advised to opt for IB Certificate courses.

3.3.6 The equivalency of other qualifications obtained will be taken into consideration for insert students.

3.4 In cases of over subscription, places will be offered first to all internal applicants who can satisfy the standard entry requirements and then to external applicants.

4. Internal Probation and Retention

4.1. In order to meet the individual educational needs of our students, they may be placed on probationary promotion or retention in their current year level. Such procedures are only used in extreme cases, where students are struggling to meet the minimum expectations of the school, and are never used as a punishment for poor behaviour.

4.2. In order to achieve 4.1, teachers are asked to centralise basic academic and pastoral data at least 2 times per year. This data will then be used to ascertain any students who may be struggling to meet our minimum requirements and are in need of additional support. Pupils will be placed on Academic, Pastoral or SEN Support Programmes, depending on which will best meet their needs.

4.3. Teachers can also nominate students for probation or retention by informing the appropriate Senior Teachers (Academic), Heads of Year (Pastoral) or Student Guidance Officers (SGOs).

4.4. The criteria for consideration of probation and retention in Primary and Secondary is as follows:
